	<p><i>This covers: where you live, who you see, children, what you eat, medical issues etc</i> If there is a fit surviving parent they would look after the children but if not it will be up to the Court to decide <i>unless</i> you have a Lasting Power of Attorney – Health & Welfare (Introduced Oct 2007) See: www.LastingPowersofAttorneyuk.com</p>
